





THE MAIN EXCLUSIONS OF THIS CONTRACT

We are transparent! You will find all the exclusions and information on our General Conditions.

Exclusions specific to assistance and medical expenses guarantees

- Relapses of illnesses or accidents prior to the effective date of the contract, including chronic illnesses and consolidated illnesses.
- Pregnancy, maternity costs and voluntary termination of pregnancy.
- Vaccines, comfort treatments, the cost of glasses, contact lenses, prostheses of any kind, health checks, test exams or routine treatments (e.g. acne, back pain, contraception, etc.), preventive or control measures not consecutive to an accident or illness guaranteed.

Exclusions common to all warranties

- The absorption of drugs, narcotics, analogous substances and medicines not prescribed by an authorized medical authority and their consequences.
- The consequences of the alcoholic state of the Insured.
- Nervous or mental illnesses.
- Sports practice on a professional basis, the practice of an amateur race requiring the use of a motor vehicle and the use of an ultralight, hang glider, flying wing, parachute or paraglider.
