





MEDICAL EXPENSES IN FRANCE	Extension of the guarantee up to 90 days in the event of temporary and/or definitive return. From 210 €
EXTENSION BAGAGES	Modification of the guarantee up to €3,000 instead of €2,000. From 30 €
AVA SPORT+	Extension of research costs raised to €25,000 and practice of dangerous air sports. 10 €/month

THE MAIN EXCLUSIONS OF THIS CONTRACT

We are transparent! You will find all the exclusions and information on our **General Conditions**.

- Relapses of illnesses or accidents prior to the effective date of the contract, including chronic illnesses and consolidated illnesses.
- Vaccinations, medical check-ups and comfort treatments, including: acne and allergies, back pain, contraception, cost of glasses.
- Accidents caused intentionally by the insured.
- The absorption of drugs, narcotics and medicines not prescribed by a doctor.
- The consequences of the alcoholic state of the Insured characterized by the presence in the blood of a pure alcohol level equal to or higher than that fixed by French law.
- Preventive treatments and health check-ups.
- A pregnancy already known before the start of the contract
- Nervous or mental illnesses
- Sports practice on a professional basis and amateur racing using a motor vehicle
